



# Full Fee Paying Overseas Students 2017

## 1. TUITION FEE

• Years 7 and 8	\$A11,840 per semester	\$A23,680 per year
• Years 9 and 10	\$A11,145 per semester	\$A24,290 per year
• Years 11 and 12	\$A12,585 per semester	\$A25,170 per year

## 2. BOARDING FEE

For all year groups	\$A9,843 per semester	\$A19,685 per year
Which includes GST of	\$A318 per semester	\$A635 per year

## 3. PAYMENT OF FEES

It is a condition of the visa for an overseas full fee paying student, that Tuition (and, if applicable, Boarding) fees for each semester are paid prior to the commencement of the semester.

## 4. ANCILLARY CHARGES

An allowance should be made for the possible inclusion of ancillary charges. These are suggested amounts and the actual charge may vary according to the individual needs of the student.

Uniform (compulsory) (initial outfitting)	\$A1,300
Text Books (VCE subjects only)	\$A500 per year
Stationery	\$A150 per year
Overseas Student Health Cover Premium (see below)	\$A500 per year
Vacation/Homestay Accommodation	\$A2,850 per year
Camps and Excursions	\$A300 per year

Please note the above ancillary costs **do not** include pocket money, Year 11 Ball (including hire of dress/ suit and shoes), personal expenses, telephone calls, Year 9 elective camp or Year 12 compulsory camp.

The annual cost **does** include boarding house tutorials, flight confirmations, airport pick-up at the commencement of the school year and delivery to the airport at the end of the school year **only**.

## 5. HEALTH COVER

All overseas full fee paying students are required by the Australian Government to take out "Overseas Students Health Cover". The annual cost of this cover for 2017 will be around **\$A500**, incl GST.

## 6. VCE EXAMINATION FEE

Please note that for students undertaking studies in Years 11 and 12, a VCE Examination Fee will be required. The maximum fee for 2016 was **\$A420.60**. Fees for 2017 have not yet been published.

## 7. USE OF PERSONAL INFORMATION

The information provided by a student to Gippsland Grammar may be made available to Commonwealth and State agencies and the Fund Manager of the ESOS Assurance Fund pursuant to obligations under the ESOS Act 2000 and the National Code of Practice for Providers of Education to Overseas Students.

The School is required to tell the Department about certain changes to the student's enrolment and any breach by the student of a student visa condition relating to attendance or satisfactory academic performance.

The overseas student has a duty to advise the School of any change of address while they are enrolled as a student.
